I have completed these reports in collaboration with Restorative Justice programs and have a clear understanding of the alternative measures available in our region. I have worked directly with the court system as a Probation and Parole officer. I am well versed in the court process and criminal code, especially as it pertains to those with Indigenous ancestry.

I aimed to provide reports which offered a comprehensive narrative to highlight the individuals unique experience within their culture and the systemic barriers present in the lives of those involved. I completed in depth collateral contacts with the family, community and local resources. I noted that many of the stories followed matrilineal lines and the female voices were of the most memorable at times, as women are so often keepers of the oral history. I also received many accounts from residential school survivors and their families.

Through my position as an Integrated Social Services Worker, I have deepened my understanding of the barriers present for Indigenous people in our area. I have further strengthened my knowledge of social programs, housing and the legislation governing these services.

I have comprehensive training in Motivational Interviewing techniques and have developed essential Crisis Intervention skills. I have extensive experience working with those impacted by addictions, domestic violence and trauma and gathered a network of service providers in our region for consultation and referral.
