#### Hi Cecilia

I acknowledge your request for 4 sick day to have knee surgery, however, this type of surgery usually requires more time off work than you are proposing. Therefore, I will require the following:

- Please develop a workplan with your manager outlining what type of tasks you will be performing at home during your recovery. Please ensure the workplan is for at least 6 weeks post surgery.
- Please take your workplan to your attending physician for his review.
- Your physician must provide a note/letter clearing you to perform the duties outlined in your workplan, but also that you can begin these tasks 4 days after your surgery.

This requested note/letter will serve as your Dr.'s note which is required after 3 consecutive sick days, as per policy. Also, please provide me with a copy of your workplan and Dr.'s note for your file.
