Ms. Toset did not receive her notification of acceptance as a registered Indian in accordance with section 6(2) of the Indian Act, until October, 1994. At that time Ms. Toset notified the corporation (see letter attached dated October 13, 1994 from the Indian and Northern Affairs Canada) that she was a status Indian, and therefore was exempt from income tax. Up until notification, the corporation deducted a total of \$2,439.20 of income tax for the taxation year 1994 and remitted this amount to the Receiver General For Canada on behalf of Ms. Toset.

I would like to add that, should you disagree with this decision, you may submit a protest within three years by providing notice in writing to the Registrar stating the grounds for the protest. These grounds should specify how, in your opinion, the Registrar has failed to correctly apply the registration provisions of the *Indian Act* in your case or which points of information which you have provided have not been taken into account by the Registrar in reaching her decision. Further, there must be evidence that an application for registration as an Indian was made and a subsequent decision was rendered by the Registrar with regards to the case under protest.
