Synopsis:

On January 11th 2024 at 22:38 hours, Billy HEAD (1986/ [REDACTED]) called 9-1-1 advising that Ricki DESMOULIN smashed a window on his residence with a stick and requested police attend.

At 22:42 hours, PC BERARD was transporting DESMOULIN to Geraldton District Hospital for a separate occurrence and DESMOULIN advised PC BERARD that she broke the window. DESMOULIN was highly intoxicated. PC BERARD advised PC CHIAROT of DESMOULIN's utterance.

At 23:00 hours, PC CHIAROT arrived at 129 Beaver Road in Long Lake 58 First Nation and spoke to HEAD. HEAD advised PC CHIAROT that DESMOULIN had smashed the front exterior window of the residence with a stick. PC CHIAROT observed the window to be broken right through to the interior of the residence. PC CHIAROT obtained an audio statement from HEAD. In the statement HEAD advised that he was at his residence with his niece and DESMOULIN drinking alcoholic beverages when DESMOULIN began acting irate. HEAD advised DESMOULIN to leave and as DESMOULIN walked out the front door of the residence she grabbed, what HEAD advised was possibly a hockey stick, and smashed the front exterior window of the residence. HEAD provided a description of what DESMOULIN was wearing, Jacket with a grey hoodie underneath, Black pants, and Red and black shoes. PC CHIAROT confirmed the description with PC BERARD who was at the hospital with DESMOULIN.

On January 12th 2024 at 00:24 hours, PC CHIAROT attended Geraldton District Hospital and placed DESMOULIN under arrest for Mischief under \$5,000.00. PC CHIAROT read DESMOULIN her rights to counsel and caution verbatim from an issued OPP warrants card.

At 00:29 hours, PC CHIAROT released DESMOULIN on a form 10 - undertaking with conditions.

As a result of the investigation, DESMOULIN is charged with (1) count of Mischief Under \$5,000.00 contrary to section 430(4) of the Criminal Code.

History:

Ricki DESMOULIN had an outstanding Bench Warrant for her arrest from the 18th of April in the year 2024 involving two separate counts of Mischief Under \$5,000.00 contrary to section 430(4) of the Criminal Code.

Synopsis:

On May 17th 2024 at 12:30 hours, PC CHIAROT was conducting general patrol when he saw a female matching the description of Ricki DESMOULIN standing on Queen Street in Longlac. PC CHIAROT approached the female in an attempt to further investigate and spoke to the female. Upon questioning the female identified herself as "Dawn DESMOULIN". PC CHIAROT advised DESMOULIN that it was an offence to identify herself as someone else to avoid arrest in which DESMOULIN responded again that she was Dawn DESMOULIN.

PC CHIAROT conducted an RMS query on Ricki DESMOULIN and was able to identify the female as Ricki DESMOULIN. At 12:31 hours, PC CHIAROT placed DESMOULIN under arrest on her outstanding bench warrant and for Personation with intent to avoid arrest. Upon her arrest the female then confirmed her identity with PC CHIAROT by advising she was in fact Ricki DESMOULIN.

PC CHIAROT transported DESMOULIN back to detachment where she was lodged in cells to appear for video bail court.

As a result of the investigation, DESMOULIN is charged with (1) count of Personation with intent to avoid arrest contrary to section 403(1)(d) of the Criminal Code.
