SYNOPSIS:

On 21 September 2022 at approximately 0928 hrs in the FNT of Aroland, Cst. WESLEY and Cst. WILSON recieved a call for service from TBPCC regarding a sexual assault investigation. The complainant, Cindy ATLOOKAN, states that her children were residing with her parents Lillian and John ATLOOKAN for the last couple of years. The children

recently returned to her care approximately 5 days ago and disclosed to her that they were sexually assaulted by their 14 year old cousin, Lennon ATLOOKAN. Cindy ATLOOKAN has concerns that Lennon ATLOOKAN's mother Helen ATLOOKAN was also involved with the assault.

Cindy ATLOOKAN states that her son is bruised, and was physically assaulted as well. Cindy's children are, Eleesha ATLOOKAN, Jesiah ATLOOKAN and Lacei ATLOOKAN.

At 0946 hrs, Cst. WESLEY contacted D/Sgt Blasizzo to advise him of the sexual assault investigation. D/Sgt Blasizzo requested that officers speak to the complainant to obtain more information.

At 0958 hrs, Cst. WESLEY and Cst. WILSON attended 40 Poplar. Lillian ATLOOKAN answers the door and states that Cindy ATLOOKAN resides in Sarnia ON. Lillian states that Cindy does not have a phone number. Lillian is visibly hostile with POLICE when questioned about Cindy's whereabouts, and states "What did she do now?". POLICE provide no information regarding the investigation.

At 1018 hrs, Cst. WESLEY provides an update via email to D/Sgt Blasizzo.

At 1020 hrs, Cst. WESLEY attempts to contact Cindy ATLOOKAN with negative results.

At 1030 hrs, Cst. WESLEY and Cst. WILSON attend Tikinagan Child and Family Services in attempts to obtain contact information for Cindy ATLOOKAN. Cindy's children were not apprehended with Tikinagan Child and Family Services, therefore they do not have contact information for Cindy. Cst. WESLEY speaks with Colleen WESLEY, who states that she is able to contact Cindy ATLOOKAN via FaceBook. Colleen states that she messaged her, and advised her to contact POLICE.

At 1620 hrs, Cst. WESLEY attempts to contact Cindy ATLOOKAN with negative results.

At 1642 hrs, Cst. WESLEY attempts to contact Cindy ATLOOKAN with negative results.

22 September 2023:

At 0831 hrs, Cst. WESLEY attempts to contact Cindy ATLOOKAN with negative results.

At 0915 hrs, Cst. WESLEY contacts Cindy ATLOOKAN. Cindy expresses that she is upset that it took POLICE a while to contact her. Officers advise Cindy that they have been making efforts to contact her, but the phone line would reach a dead end. Cindy states the following to police:

- that Lennon ATLOOKAN is verbally, mentally and physically abusing her children
- that Lennon is a "spoiled brat"
- that she is frustrated towards her parents due to the way she (Cindy) was raised

Officers ask Cindy if anything sexual occurred, to which she replies that she doesn't know yet and hasn't been able to ask her children.

Cindy discloses that Lennon hit her son Jesiah ATLOOKAN with a metal stick. Cindy expresses concern because her daughter is traumatized and often pees the bed a lot. Cindy also has a 25 year old son that currently resides at 40 Poplar Crescent.

Officers advise Cindy that they will be in contact with the Detective Sergeant to see if Sarnia PS could assist with the investigation. Cindy is reminded that
