Aurora Bouchard has been approved for diversion as well. Please consider this email as written confirmation of such. I spoke with her sister who expressed concerns with Aurora as it pertains to alcohol. I just wanted to note that. Here's the synopsis:

On the evening of May 16th, 2024, Tessa MAZINAKOUSKANG could hear a disturbance inside her residence via security cameras and called the Greenstone OPP to ensure the well-being of her daughter.

Upon police arrival, all parties were gone. Kyle MICHANO was standing outside the residence and advised police that Tamara SINGLETON and Aurora BOUCHARD had taken off on foot, and he assisted MERCIER in locating her uncle, Christian TOWEGISHIG (1982/11/15), at 103 Centennial Drive.

Police spoke with TOWEGISHIG and MERCIER, ascertaining through an audio statement from MERCIER the following:

-Aurora BOUCHARD was at home with MERCIER, and invited a friend, Tamara SINGLETON over.

-Both females began smoking marijuana inside the house, and an argument ensued between the two.

-MERCIER became frightened from the yelling and began crying.

-BOUCHARD entered MERCIER's room and told her that if she did not stop crying she would throw her down the stairs. (It should be noted that the stairs inside these apartments are approximately 15 feet in height to the second story.)

-Tessa MAZINAKOUSKANG then got ahold of BOUCHARD and directed her and her friend to exit the residence.

BOUCHARD was located a short time later on foot in Longlac and arrested for Uttering Threats to Cause Death or Bodily Harm, contrary to section 264.1(1)(a) of the Criminal Code.
