#### Case File Synopsis

Accused: Edward Alexander Fisher JR, known as EJ Fisher (16OCT1987)

Occurrence Date: February 16th, 2024

Occurrence Location: 109 York St, Longlac, commonly known as YNT Variety Store

Count 1: Theft Under \$5,000 - Shoplift contrary to section 334(b) of the Criminal Code.

#### Summary:

On February 17th, 2024 officers from the OPP Greenstone detachment were dispatched to 109 York St, Longlac for a report of a shoplift related theft. Complaint, Lise GAUTHIER advised a pair of sunglasses had been stolen on February 16th, 2024.

PC WESTON attended and preliminarily reviewed the security footage and confirmed on February 16th, 2024 at approximately 16:30 hours a male in the store wearing a black jacket and a Chicago Blackhawks toque takes a pair of sunglasses from the rack and places them on his face. The male is observed leaving the store at approximately 16:34 hours and the male has the sunglasses on his head. PC WESTON learned from employee Andrew DESJARDINS that he had been working the till on the date and time in question of the theft. DESJARDINS recalls dealing with the suspect male and knows he did not pay for the sunglasses.

On February 28th, 2024 PC WESTON reviewed security footage obtained from YNT variety for the date of February 16th, 2024. PC WESTON confirms the suspect male leaves the store with a pair of black sunglasses that were placed on his head and never paid for. PC WESTON also learned the identity of the male suspect to be a male known to him as EJ FISHER. PC WESTON has had previous interactions with EJ FISHER and believes on reasonable grounds he is the suspect who committed the offence of Theft under \$5,000 dollars.
