Hi Melissa,

Marshall Messon has been approved for diversion on his **mischief under charge**, please consider this email as written confirmation of such. The impaired matter will have to follow its own course. Here's the synopsis for the mischief under:

On February 7th, 2024 between midnight and 2:30 am Marshall MESSON attended the residence of Jade LEGARDE located at 236 Otter Road, Long Lake #58 FNT. MESSON had attended to ask LEGARDE if she wished to have drinks together. LEGARDE told MESSON she was unable to due to working in the morning. **Being told no caused MESSON to become upset with LEGARDE by yelling and swearing at her.** While yelling, MESSON took his handheld size Beats Pill speaker and **through it from inside the residence through a window next to the front door causing the window the break.** MESSON retrieved his speaker and left LEGARDE's residence.

At approximately 3:15pm PC WESTON was dispatched to a mischief at 236 Otter Road, Long Lake #58 FNT. PC WESTON attended and learned of the incident details above. LEGARDE stated she is cousin's with MESSON however is wishing to **press charges in order for Long Lake #58 FNT housing to replace the window.** PC WESTON observed a small space next to the front door to be boarded up with a piece of cardboard which was confirmed to be where the broken window had been. PC WESTON observed a small square window with the majority of the glass broken out to be located in the rear of LEGARDE's pick-up truck. PC WESTON obtained an audio statement from LEGARDE.

Based on the information obtained, PC WESTON formed reasonable grounds to arrest and charge Marshall MESSON with 1 count of Mischief contrary to section 430(4) of the Criminal Code.
