Travel from Sioux Lookout to Halifax via Winnipeg to attend the 2024 National Family Law Conference as approved in Travel arrangements 001095.

Traveled by personal vehicle Sioux Lookout to Winnipeg 989 kms return.

Overnight in Winnipeg Hampton Inn July 20th to catch scheduled WestJet direct flight to Halifax on July 21. Left personal vehicle at hotel parking lot and took airport shuttle avoiding expensive airport parking fees.

Airport Taxi flat rate \$80.00 one way total \$160.00 return. Note Halifax airport more than 30 kms from downtown hotels and usually takes about 45 minutes to travel to downtown Halifax hotels.
