Weight Limit: 44lbs/20kgs Maximum 2 bags per passenger **Excess Baggage:** Excess Baggage over 44lbs/20kgs is charged at excess baggage rates. Maximum weight accepted for excess baggage at check in is 26lbs/12kg. Anything over 26lbs/12kg must be shipped as cargo. Carry On:

13lbs/6kgs 9"×16"×22.5"/22.5cm×40cm×56cm

Infants who are not paying a seat are not allowed the free 44lbs. They are only allowed one collapsible stroller.
