NEW Requirements at Check-In

Transport Canada introduced mandatory vaccination requirements to help keep you safe when travelling. These measures are evolving so it's important to be aware of the requirements at your departure, connecting, and arrival locations in your itinerary. Terms and Conditions

- Flights operated by Perimeter Aviation operate from the Perimeter Terminal at 626 Ferry Road.
- Flights operated by Bearskin Airlines operate from the James A. Richardson International Airport.
- Passengers who have booked through travel that transits between Perimeter's Terminal and the Winnipeg Int'l Terminal will be provided a taxi voucher.
- Interline travel with Bearskin Airlines and Wasaya Airways operates from the James A. Richardson International Airport in Winnipeg with Bearskin Airlines and connects in Red Lake or Sioux Lookout to Wasaya Airways.
- Reservations not claimed by the time Check-in closes will be cancelled and subject to forfeit based on fare purchased.
- We reserve the right to change tariffs and flight schedules without notice. We also reserve the right to re-route or combine flights in order to maintain daily service.
- Passengers can be denied boarding due to insufficient identification, and/or incapacitation due to alcohol or drugs, and/or safety concerns.
- If extra time and/or assistance is required when boarding the aircraft, or if you require a special lift onto an aircraft, please contact us to ensure the proper equipment is available when you arrive.
- Through checked baggage is not accepted when transiting between the two terminals.

Checked Baggage

- The total free baggage allowance per passenger (includes checked, carry on and carry out) is 60 lbs. A maximum of 4 pieces are permitted as checked baggage. Personal baggage in excess of these allowances (in weight and/or number) will be subject to excess baggage fees and will travel on a space available basis.
- All baggage must be checked in at once. No additional baggage will be accepted after passenger boarding passes have been issued.
- All baggage must be properly packaged and taped with identification attached to each item before checking it in. For your protection, pack essential and valuable items (such as medication) in your carry-on baggage or on your person.

Carry-on Baggage

A maximum of 2 pieces are permitted and form part of the free baggage allowance weight. Carry-on baggage must not exceed 40cm x 33cm x 20cm (16" x 13" x 8") in dimension with maximum combined weight of 13 lbs. Eligible pieces include soft-sided briefcases, laptops. purses & small backpacks. Carry-on baggage must fit in the sizer located at the check-in counters.
