Checked Bag:

Weight Limit: 44lbs/20kgs

Maximum 2 bags per passenger

Excess Baggage:

Excess Baggage over 44lbs/20kgs is charged at excess baggage rates.

Maximum weight accepted for excess baggage at check in is 26lbs/12kg. Anything over 26lbs/12kg must be shipped as cargo.

Carry On:

13lbs/6kgs 9"×16"×22.5"/22.5cm×40cm×56cm

For this journey, the baggage rules of AirCreebec apply.

Infants who are not paying a seat are not allowed the free 44lbs. They are only allowed one collapsible stroller.

In case your checked baggage exceeds the free baggage allowance or standard dimensions, excess baggage charges will apply. Please also acknowledge the regulations for sport and special baggage.
