Carry On: 13lbs/6kgs 9"×16"×22.5"/22.5cm×40cm×56cm For this journey, the baggage rules of AirCreebec apply.

Infants who are not paying a seat are not allowed the free 44lbs. They are only allowed one collapsible stroller.

In case your checked baggage exceeds the free baggage allowance or standard dimensions, excess baggage charges will apply. Please also acknowledge the regulations for sport and special baggage.
